

Justified Gallery Pro

The Justified Gallery extension is a grid based gallery which adapts to the screen size dynamically. The gallery supports images with different sizes and aspect ratios, the images will automatically be re-arranged based on the available space.

This extension uses Miro Mannino's Justified Gallery jQuery plug-in:

Justified Gallery can be used in responsive layouts (with breakpoints) or inside a layout grid for full width/flexible layouts. Clicking on one of the images will trigger a lightbox slideshow or open a link.

Adding images

Click 'Add' to add a new image. To add multiple images at once, hold down the SHIFT-key on your keyboard while pressing the Add-button.

Images can have different sizes and aspect ratios.

Row height

The preferred height of rows in pixel.

Max row height

This option could be a false or negative value to keep it disabled.

Could be a number (e.g 200) which specifies the maximum row height in pixel.

Alternatively, a string which specifies a percentage (e.g. "200%" means that the row height can't exceed 2 * rowHeight). Note that with this option can crop the images if they need to be higher to be justified.

Margin

Specifies the margins between the images.

Last row

Specifies how to align the image in the last row.

- **justify**
Justifies the last row
- **left**
Align images to the left (no justify)
- **center**
Align images to the center
- **right**
Align images to the right
- **hide**
Hide the row if it can't be justified.

Border

Specifies the border size of the gallery. With a negative value the border will be the same as the margins.

Randomize

Automatically randomize the order of photos.

Filter

This option makes it possible to apply a filter to the thumbnail images. The filter will be removed when the mouse is hovered over the images.

The following filters are available:

- sepia
- grayscale
- blur
- opacity – light
- opacity - dark

Lightbox

Justified Gallery Pro also supports lightboxes so when you click an image then a lightbox slideshow will be launched. Most WWB lightbox add-ons are supported:

To customize the behavior of the lightbox, you can add extra options through 'Options'. Please consult the documentation or website of the specific lightbox for more details about possible configuration options.

Caption

Specifies the styling of the caption. It's possible to display never, always or on hover. If the vertical alignment is set to 'middle', then the caption will cover the full image.

Load More

This feature is also known as "Infinite Scroll".

'Images per page' specifies how many images will be initially displayed.

The 'Load more' button can be used to load more images on demand.

To disable 'Load more' functionality, set 'Images per page' to 0.

How to install this extension so it is available in WYSIWYG Web Builder?

You can use the Extension Manager (Menu->Tools->Extension Manager) to install this extension.

Alternatively, you can manually copy all files from the zip file to the Web Builder extensions folder. Usually this folder is in this location:

My Documents\WYSIWYG Web Builder\system\extensions\
